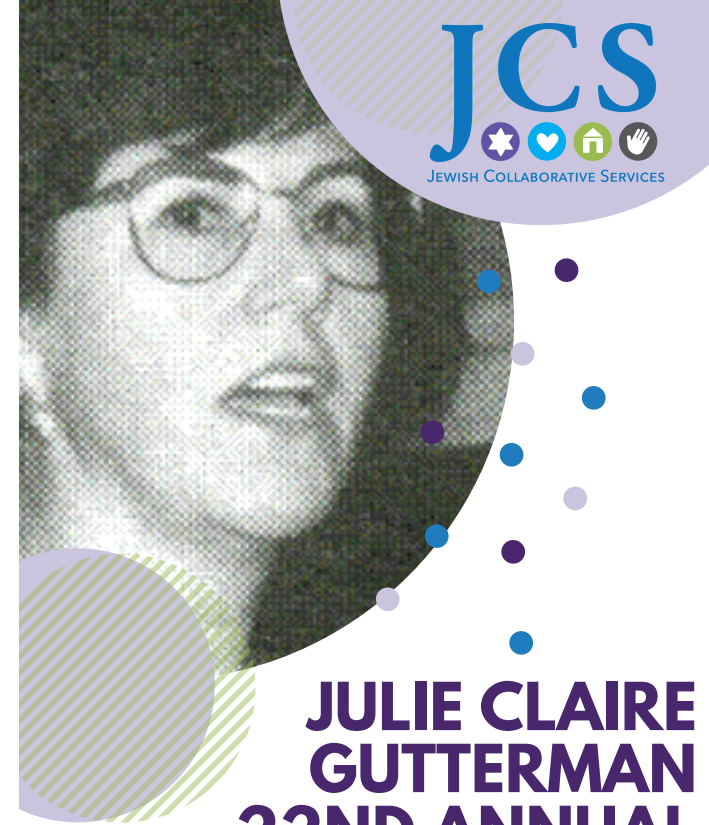

"Enhancing Practice for Healthy Communities in Response to Societal Violence"

This session is intended to push beyond the counterproductive rhetoric and binaries, to engage with the systemic factors that contribute to the culture of violence, and to acknowledge that the same systemic patterns of behavior that drive oppression also underpin socialized violent tendencies, such as mass shootings.

Objectives

- 1) Understand the systemic influences that compel violent actions and the ways in which these intersect with professional practice.
- 2) Utilize the Ecological Systems Model to examine the spheres of influence that socialize humans toward violence.
- 3) Apply the complementary frameworks of trauma-informed care and culturally responsive practice to enhance the capacity of practitioners in response to violence in society.
- 4) Map professional ethics to the issue of societal violence and identify how those ethics can be applied in response to the complexity of societal violence.
